

## Call for Artists

D'Arte Centre Gallery & the Harlingen Art Forum Announce a Juried Exhibition entitled:

The Family Crisis Center in honor of National Child Abuse Prevention & Awareness Month

Topic is open for artistic interpretation, "Inner Child" will be a juried exhibition with first (\$50 & ribbon), second (\$25 & ribbon) and third (ribbon) place prizes as well as a Kid's Choice Award (ribbon). Works in ALL media qualify as long as the following size limitations are adhered to. Artists may submit multiple works, one work for each submission form and \$10 jury fee. A special category for Student Art will be available, student artists must be currently enrolled and provide school (or home school) information on entry form. Student entries will not require payment and works will be judged separately and only award ribbons will be given.

**Eligibility:** Finished 2D Works (including framing) must not exceed 36"Wx48"H. 3D works must not exceed 36"Wx36"Dx60"H. Works must be gallery ready with appropriate mat, frame or display device. Unframed works must have painted or otherwise finished edges. No exposed canvas and staples will be displayed or judged. Hanging works must be wired. [Other works will be accepted, but only works within these dimensions will be judged and eligible for prizes. There are no refunds of entry fees.] No obscene or objectionable themes. Entries not meeting these display requirements may not be exhibited, there are no refunds of entry fees. Determination of suitability for display will be at the sole discretion of D'Arte Centre Gallery Director and is final.

**Judging:** Will be by a panel of artists. All decisions of the judges are final. Prizes will be awarded at an exhibition Open House and Reception on April 21st, 6 to 9 pm, artists are encouraged but not required to attend.

**Method of Entry:** Works must be delivered to D'Arte Centre Gallery before 5pm April 3, 2010 and must be accompanied by a completed entry form and entry fee payment.

**Sales:** Works should be available for sale; D'Arte Centre Gallery will deduct a 30% commission on all sales. **Artist may choose to donate a percentage of their profit or winnings to the Family Crisis Center in honor of Child Abuse Awareness Month.**

**Donation amount should be indicated on the Entry Form.** *The Family Crisis Center (616 W. Taylor, Harlingen, Texas 78550, (956) 423-9305, www.familycrisisctr.org) is a corporation organized to provide temporary shelter and sustenance for women and their children who are victims of domestic violence; to provide educational and counseling services for victims of sexual assault and domestic violence and victims' families; and to undertake all lawful activities for the protection and assistance of victims of sexual assault and domestic violence; and to educate the community on these issues.* Payment for sold works will occur after April 30, 2010. All works must be picked up from D'Arte Centre Gallery between May 1, 2010 and May 12th, 2010. Artworks remaining after May 15, 2010 become the property of the Harlingen Art Forum and may be disposed of as the HAF Board sees fit.

**Entry Form:** Required to be completed for each entry. This form, payment and work should be delivered to: D'Arte Centre Gallery, 115 E Jackson, Harlingen, TX 78550 between 10 am and 5 pm, by April 3, 2010.
